These items were put on display at the Rotary International Convention in Montreal. In addition, several other knitted, crocheted, or hand quilted items were donated for the convention booth. All items were exchanged for donations to The Rotary Foundation PolioPlus fund. The Fellowship raised approximately \$3,000 towards the eradication of Polio.
